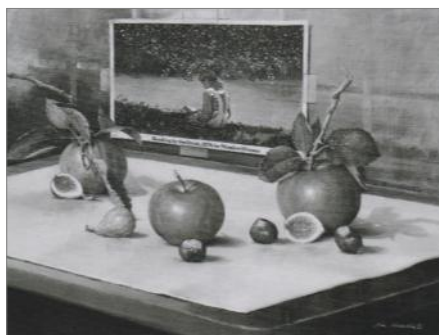

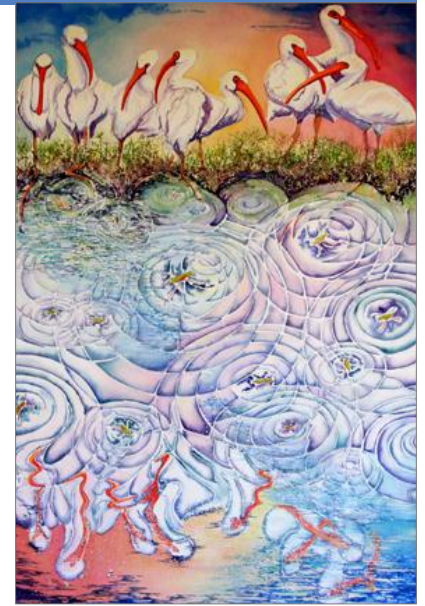

An Artist's Dream

I've heard stories of it happening, but this time I was chosen. I need to share this experience to encourage other artists to create from the heart. Keep reaching to achieve. Know what your media will do. Study and use the classic elements of composition.

Four years ago I joined the Tallahassee Watercolor Society where I found warm and friendly artists who openly offered their support, knowledge and experience. With their help my paintings improved. Gradually they were accepted into juried shows and exhibitions. Selling my paintings was a different thing. During this time I learned that an artist can try to paint to sell, however, I was much happier painting from my heart.

During the months of May and June, 2010, seven of my paintings were part of an exhibit at the Artport Gallery in the Tallahassee Regional Airport. I arrived at the airport to take my paintings home as this exhibit was being taken down to make way for a new exhibit. Amanda, the curator, brought three of my paintings to me at my car and told me that there was a man in the gallery who wanted to buy several of the others.

As I entered the terminal, a young man dressed in an expensive black suit approached me in front of the gallery. He asked if I was Linda. It took a few seconds for me to realize that he was holding one of my business cards that had my picture on it along with my contact information. We proceeded into the gallery where four of my paintings were leaning against a wall. Something about my paintings caught this man's eye, for he had just landed in Tallahassee and walked

past the gallery as the exhibit was being dismantled. What a stroke of luck it was that I was also at the airport.

We discussed the paintings. I told him the story behind each work. He liked the strong color. Then he began to point out subtleties in my composition and technique. That was when I realized he knew a lot about art. When this man asked what I charged for each of the three paintings he was interested in, I was scared this discussion would end. I told him. He paused to think. That pause seemed to last a long time. He then offered a substantial amount of money for three of the paintings. All I could think of was, "Is this a dream?" I accepted.

Now the business of art became the mindset. There were problems to solve. This man was returning to Miami the evening of the same day and wanted to take the paintings with him. All the paintings needed to be packed into one box to eliminate extra baggage charges. An employee at a UPS store where I do business successfully packaged them for me. We met again at the airport later that afternoon where I handed over the box of paintings. At this point he offered another surprise. He wanted a fourth painting done in my style of Snook swimming among the roots of Mangrove trees. I have three months to create it.

I learned that faith often plays a role in the business of art. Out of the clear blue sky a person came. In the last seconds of an exhibit something drew him to my paintings. Was it truly by chance that our paths crossed in those last seconds? I now have a new patron of my art which is something every artist dreams and prays about. Thank you, God. —Linda

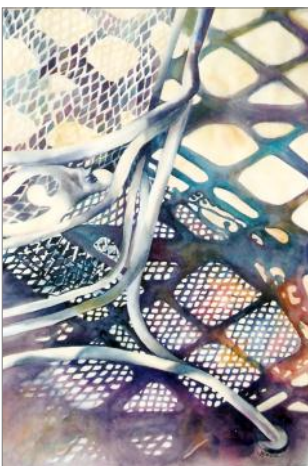
