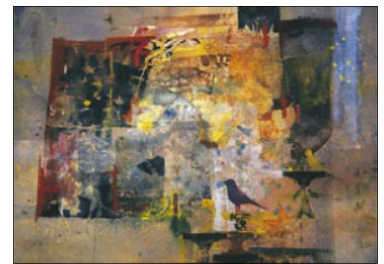

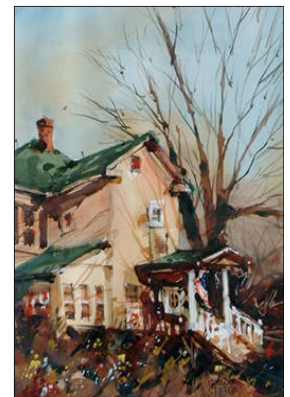

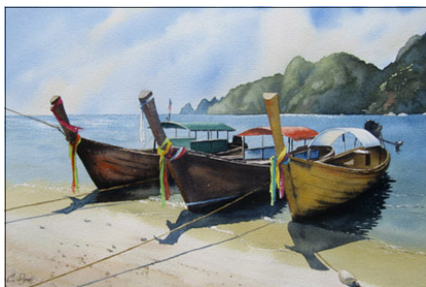

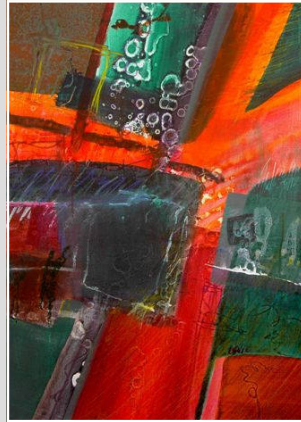

This first work reflects my fascination with nature as it reflects the nature within each of us, the building, loss and rebuilding done in our lives, as well as the conflicts that result from those very activities. We mirror nature, and are a part of it, not an authority over it.

The brevity of nature is compelling; conversely, its tenacity can be overwhelming. Watching the careful, or careless, construction of a bird building its nest reminds me of relationships, not only individually by globally as well. As one who is tenacious about little, my natural inclination is to explore any possible avenue, which allows me to give evidence of my experiences, revealed in "Aftermath I."

Our lives are perpetual motion, weaving response, visual stimuli, auditory assault, and social conditioning. From the very earliest days we are being fashioned into a persons of consequence, as life is not without aftermath. We learn well how to lie to ourselves as a mechanism of dealing with that aftermath. As we re-invent ourselves with external lies, we encounter those, all too often, that make lying a way of life.

As a continuum of the good, bad and ugly in our lives, we weave those aspects into something tolerable, blending them until they can no longer be witnessed individually. It is from this that I paint, and weave, in a painterly fashion, my water media on paper.

A portion of my work addresses the social issues with which I was raised, the social "issues" which I was forced to experience, and those issues with which I grapple today, in particular, those areas intersected and woven with lies, albeit in an abstract/expressive style. "Tree of Knowledge" is a blending of my life and beliefs. ~

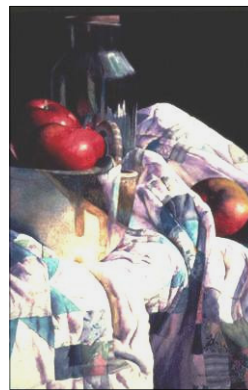

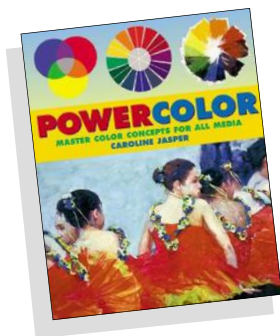
**Kathryn K. Rileigh**, Brevard NC, had her painting "Anchorage" juried into the First Frontier Collage Society Exhibition in Texas.

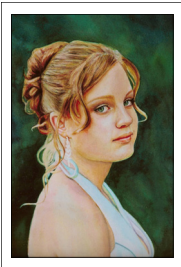
