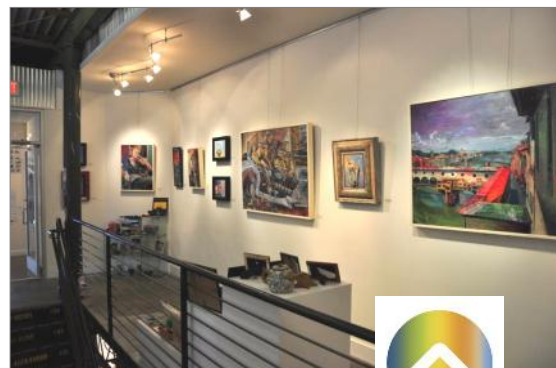

Kate's work was featured in an 8-page spread in *American Artists Watercolor Magic*, Summer 2005 called "Rolling on the Color." Hot Springs Gallery in Arkansas does one of the most succinct statements about Kate's work. Kate, who usually works with the unclothed figure is a NC artist "who frequently uses no brush at all choosing instead to apply watercolor and gouache to paper with printmaking rollers. Although her approach is a radical departure from the techniques associated with traditional watercolor, she finds it allows her to create breathtaking bold paintings." Kate will also be the featured artist at the **City Art Gallery**, 511 Red Banks Rd., Greenville, NC, during your visit, and the gallery will

be hosting an **Opening Reception** for her on Thursday, April 14 from 6–8 PM while the workshop is going on. Members and guests are cordially invited.
